Agreements:

By submitting to this competition, you agree to allow your film, if selected, to be shown at the TULALIP FILM FESTIVAL (TFF) and at any special event or fund raiser held specifically for the promotion of the TFF and its affiliate festival organizations. The TFF reserves the right to use excerpts and stills from your film for the promotion and advertising of the actual film festival and the organization's special events.

Disclaimer:

All care will be exercised in handling all entries, but neither the TFF judges, organizers, employees, sponsors, nor participating organizations assume responsibility for any damage to or loss of materials submitted.

Judging:

All entries are reviewed by a panel of judges selected by the TFF. ALL submissions will be viewed and critiqued by the panel from March through July of 2007. The finalists will be determined by the TFF on or around the middle of August, 2007. Selected filmmakers will be notified by e-mail of their acceptance into our Festival. We currently accept DVD or MiniDV submissions. If submitting a DVD, it is best to have it professionally mastered, as home-burned discs tend to skip and freeze even on high end equipment.

This is not required, but is recommended. A badly skipping DVD will not be screened.

WAIVER: (The legal mumbo-jumbo)

Release, Waiver and Indemnification. BY ENTERING THE CONTEST, ENTRANTS RELEASE, WAIVE ANY CLAIMS WITH REGARD TO, AND HOLD HARMLESS THE PROMOTER, THE HOST AND THE CONTEST ENTITIES FROM AND AGAINST ANY AND ALL CLAIMS OF ANY KIND THAT ARE OR COULD BE ASSERTED WITH RESPECT TO ANY MATTER RELATING TO THE CONTEST. ENTRANTS FURTHER AGREE TO INDEMNIFY, DEFEND AND HOLD THE PROMOTER, HOST AND ALL OTHER CONTEST ENTITIES HARMLESS FROM ANY AND ALL DAMAGES, LIABILITIES, FEES AND COST INCURRED IN DEFENDING AGAINST ANY THIRD PARTY CLAIMS OR THREATS OF CLAIMS ASSERTED AGAINST PROMOTER, HOST AND/OR OTHER CONTEST ENTITIES ARISING FROM ANY ENTRANT'S PARTICIPATION IN OR CONDUCT ASSOCIATED WITH THE CONTEST.

Force Majeure: Nonperformance of any party shall be excused to the extent that performance is rendered impossible by strike, fire, flood, earthquakes, war, governmental acts or orders or restrictions, or any other reason where failure to perform is beyond the reasonable control, and not caused by the negligence of, the non-performing party.

Governing Law and Waiver of Damages: The contest and these official rules are governed by and shall be construed in accordance with the laws of the Tulalip Tribal Government and The United States of America, without regards to its principles of conflicts of law. For any dispute not subject to arbitration, entrant agrees to personal jurisdiction by the tribal courts located in Tulalip, Washington, United States of America, and waives any jurisdictional, venue, or inconvenient forum objections to such courts. Further, in any such dispute, under no circumstances will entrant be permitted to obtain awards for, and hereby irrevocably waives all rights to claim, punitive, incidental, or consequential damages, or any other damages, including attorneys' fees, other than participant's actual out-of-pocket expenses (i.e., costs associated with participating in the contest), and entrant further irrevocably waives all rights to have damages multiplied or increased.

Privacy: Information submitted in connection with the contest will be treated in accordance with these official rules and the TULALIP FILM FESTIVAL's privacy policy, provided that in the event of any conflict between these official rules and such privacy policy, the terms and conditions of these official rules shall prevail. All contestants and team members hereby acknowledge and agree that the promoter will have access to some or all of their personally identifiable information, including but not limited to registration information collected by the host.

Participation in the TULALIP FILM FESTIVAL implies understanding and acceptance of all terms included in the Rules & Guidelines and Submission Agreements contained in this document.
